1) FEES

Equine Associates, LLC and Employees are devoted to top-notch horse care.

Board, including (but not limited to); stabling, feeding up to 4x/day, mucking, turnout and night check is provided by EALLC at the rate of \$1200/month.

Training includes five/days/week at the rate of \$1200/month. Private lessons can be arranged upon prior organization with Jontelle Forbus. A 30 day written notice is required prior to leaving the EALLC training/board program. Written notices can be given to: Jontelle Forbus. Written notices are not applicable in the case of sales horses.

Should said equine be sold while in training with EALLC/Jontelle Forbus, a 10% commission on the final purchase price of the horse will be owed.

3) TURNOUT

For the safety of consideration of staff and horses in the care of EALLC, we require a leather lead with a chain shank and a leather halter.

Amount of turnout will be determined according to management with consideration of the riding schedule, pasture and weather conditions. Horses are turned out individually or the option of group turnout (if all horses are compatible) exists.

4) EXPRESS ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

5) ROUTINE AND EMERGENCY CARE

If medical treatment is needed, EALLC will attempt to call the Owner, but in the event the Owner can not be reached, EALLC, has the authority to secure veterinary and/or farrier care. Owner is responsible to pay all costs relating to this care. EALLC is authorized as Owner's agent to arrange billing to the Owner.

EALLC agrees to implement a shoeing programs consistent with recognized standards. Owner is obligated to pay the expenses of such services.
